As you are kindly aware, under the above-mentioned constitutional provision and the law, every citizen has the right to access information from public bodies. Under the law a public body is bound to provide requested information within 10 working days. The prime objective of this law is to ensure transparency and public participation in governance and to bridge the gap between public institutions and citizens.

As per PEMRA's official information received on 3rd April, 2019, the PEMRA granted license in 2009 to First Media Services-FMS Private Limited to operate FM 100 Karachi for 10 years.


In this context, I request you to kindly provide me the certified copies of following:

- Copy of the application for request of license by First Media Services-FMS Private Limited
- State of qualification submitted by First Media Services-FMS Private Limited for purpose of issuance of license
- FMS company's registration certificate of incorporation submitted as part of the application of FMS
- Name and contact of person authorized on behalf of FMS to apply for license
- State of Annual Revenue (Audit Report) submitted by FMS during past 3 years (FY 2015), (FY 2016), (FY 2017), and (FY 2018).
